1.3 Instructions

Here is what you MUST respect to do your work:

1. If a list of function is given at the beginning of the exercise, you can ONLY use these for that exercise.

- 2. If no function name is listed at the beginning of an exercise, you can use any function you want for that exercise.
- 3. The sign >, in the exemples, represents the prompt of your shell. The line where you can write inputs.
- 4. You can do the work on team of 2 people max if you want. Only one will give a tarball back with both names in the file AUTHORS.
- 5. You MUST give back a tarball using template name: your lastname.tar.bz2
- 6. Your tarball must be clean. No binaries, temporary files, ...or any other files than the ones asked.
- 7. Your solutions to the exercises MUST run on GNU/Linux 32bits machines using Debian-like operating systems (Ubuntu is OK).
- 8. A dirty tarball will give you 0/20.
- 9. Being late when handing the tarbal will give you 0/20.

1.6 Exercise 1: Simulated port knocking

Using a nmap script, write a script to simule a port knocking system.

Use this sequence:

- knock on port 12567 with a UDP packet.
- knock on port 3615 with a TCP packet.
- knock on port 1617 with a UDP packet.
- knock on port 3617 with a TCP packet.
- knock on port 22000 with a UDP packet.

But only if the system as a SSH server running on it (port 22, version 5.x).

Write the script in a file named port_knocking.nse.

Using a nmap script, write a script to discover at least 5 DNS FQDN¹ names from the domain written on the blackboard.

Exemples are:

- ullet www.unmondelibre.fr

Of course, the exemples cannot be part of the 5 FQDN you have to find.

Write the script in a file named dnsbruteforce.nse.
